The 2012 legislative session resulted in the passage of a number of important bills that effectively advanced the priorities and objectives of the Illinois Environmental Council (IEC) and the environmental community. Particularly notable this year was the passage of bills that were part of complex, multi-year campaigns that overcame tough negotiating hurdles. Bills to update the plumbing code for conservation, to institute fees for concentrated animal feeding operations (CAFOs), and to ban BPA in children's food and beverage containers passed nearly unanimously this session.

At fourteen individual legislative measures, the 2012 list includes the largest number of bills that the IEC has ever included on a single scorecard. This fact is a true testament to the efforts of our twelve award winners, all of whom consistently voted for the environment. These leaders are all members of the House Environmental Caucus, led by retiring Representative Karen May. The significant impact of these legislators, and of the House Environmental Caucus itself, is clearly evident in our ongoing success at advancing important environmental initiatives in Springfield.

Despite our many victories this year, the environmental community's top goals for 2012 have not been achieved. SB1566, a critical measure that would fund the Illinois Department of Natural Resources, failed in the Senate by a small number of votes. Legislation to regulate new high volume hydraulic fracturing failed to move forward this year and, as a result, we are entering a time where operations may begin without sufficient regulation. Passage of these two bills is the environmental community's top priority as we move into the veto session, and will remain our primary objective throughout the 2013 legislative session.

This is the first scorecard that the IEC has published in nearly five years. IEC expects to publish this scorecard annually following the close of the regular legislative session. We are very excited to once again bring this important tool to legislators and our members. Thank you for your continued support.

Explanation of Scoring

For each bill, legislators are evaluated on whether they voted with the pro-environment position ("+") on the bill or against it ("-"). The votes are then tallied and an overall score is calculated. For instance, someone who voted proenvironment on six bills and against on four bills is given a 60% score.

The only votes not counted are those when a legislator had an excused absence (noted in the chart as "A"), which generally meant that the legislator was not in Springfield on that day due to an illness or other unexpected circumstances. Legislators who had excused absences were scored according to the other votes they cast.

Two other voting possibilities are included. On occasion, a legislator may vote "Present," which is essentially an abstention. We have counted these votes the same as a no vote on the bill because the impact on the bill's potential to pass is the same as if that legislator had voted no. These are shown in the voting chart as "P" and counted the same as a "+" when it helps the pro-environment position, and shown as "p" and counted as "-" when it hurts. Similarly, when a legislator is in Springfield but does not vote on a bill, we have counted it the same as a "no" vote on the bill. This is noted in the chart as "NV" and counted the same as a "+" when this action supports the pro-environment position.

It is noted as "NV" and counted as "-" when it does not support the pro-environment position.

Legislators have many reasons for voting "Present" or for not voting at all. They may vote "Present" because of a philosophical conflict on the issue, or simply because they don't want to commit publicly one way or the other. They may miss a vote because they were in an important meeting, were in the bathroom at the time of the vote, or were at their desk but decided not to vote. Regardless of the reason, all of these actions have significant consequences for whether or not a bill passes, and therefore we have decided that it is appropriate to hold legislators accountable for their actions whatever they may be.

Any legislator with an asterisk (*) beside their score did not complete a full term. Legislators with partial records were not awarded perfect environmental voting record awards.

Finally, there are a few instances that IEC is aware of where a legislator has asked that their vote be changed "on the record" after the vote was made. This change is recorded in legislative transcripts. Unfortunately, this does not actually change the recorded vote tally and cannot affect the final outcome of a vote. Because of this, we are unable to accurately research all of these vote changes and have based our scores only on the original votes.

About the Bills in the 2012 Environmental Scorecard

SB3811: Net Metering

Sponsors: Sen. Don Harmon and Rep. Karen May

SB3811 makes a technical fix to Illinois' net metering and energy efficiency laws to support renewable energy and conservation in Illinois.

SB3811 passed the House by a vote of 104-14 and the Senate by 48-6.

SB2950:Toxin Free Toddler Act

Sponsors: Sen. Ira Silverstein and Rep. Elaine Nekritz.

SB2950 prohibits the sale of children's food or beverage containers made with the toxic chemical bisphenol-A.

SB2950 was approved by the House 88-30 and in the Senate by 54-0-1.

HB5071: Electric Vehicle Charging Stations

Sponsors: Rep. Ann Williams and Sen. Heather Steans

HB5071 Clears the way for increased use of electric vehicles in Illinois by clarifying the law so that electric charging stations will not be regulated as electric utilities by the Illinois Commerce Commission.

HB5071 passed the House 92- 25- 1 and the Senate by 42- 10- 0.

HB3881: Environmental Justice on Landfills

Sponsors: Rep. Marcus Evans and Sen. Don Harmon

HB3881 upholds a decades old ban on new or expanded landfills in Chicago and extends this ban to Cook County.

HB3881 passed the House 63-49-6 and the Senate by 36-17-1.

Pro-Environment Vote: Yes

HB5642: CAFO Permit Fees

Sponsors: Rep. Michael Tryon and Sen. Michael Frerichs

HB5642 helps ensure that the Illinois Environmental Protection Agency has the funding it needs to fully enforce the clean water act by placing the first pollution discharge permit fees on Concentrated Animal Feeding Operations (CAFOs).

HB5642 passed the House 91-14-1 and the Senate by 42-15-0.

HB5539:Agriculture Pollution Prevention

Sponsors: Rep. Lisa Dugan and Sen. Michael Frerichs

HB 5539 places a voluntary tax on fertilizer to fund an agriculture pollution prevention research council and pollution prevention efforts.

HB 5539 passed the House 84- 22- 0 and the Senate by 50-6-0.

HB4986: Recycling Commission

Sponsors: Rep. Karen May and Sen. Susan Garrett

HB4986 creates a commission to review and recommend improvements to Illinois' recycling laws.

HB4986 passed the House 67-48-1 and the Senate by 56-0-0.

Pro-Environment Vote: Yes

SB2897: Benefit Corporation Act

Sponsors: Sen. Michael Frerichs and Rep. Sara Feigenholtz

SB2897 creates a new type of corporation called a benefit corporation. These corporations provide better legal protections to businesses that have sustainability as part of their corporate mission.

SB2897 passed the House 66- 47- 0 and the Senate by 30-21-1.

HB4496: Plumbing Code Update

Sponsors: Rep. Carol Sente and Sen. Susan Garrett

HB4496 requires the Illinois Department of Public Health to update Illinois' plumbing code to reflect new water saving technologies.

HB4496 passed the House 100- 14- 0 and the Senate by 40- 14- 2.

Pro-Environment Vote: Yes

HB4119: Shark Fin Ban

Sponsors: Rep. Sara Feigenholtz and Sen. Antonio Munoz

HB4119 bans the sale or possession of shark fins in Illinois to protect the unnecessary slaughter of threatened and endangered species.

HB4119 passed the House 81- 33- 0 and the Senate by 41- 13- 0.

Pro-Environment Vote: Yes

HB3888: Invasive Species in Lakes

Sponsors: Rep. Joann Osmond and Sen. Suzi Schmidt

HB3888 helps prevent the spread of invasive species, which can devastate ecosystems between Illinois lakes. Requires owners to remove aquatic plants or animals before transporting the vehicle.

HB3888 passed the House 104-13-0 and the Senate by 48-6-0.

Pro-Environment Vote: Yes

SBI566: DNR funding

Sponsors: Rep. Frank Mautino and Sen. Toi Hutchinson

SB1566 provides sustainable funding for the Illinois Department of Natural Resources to protect our state parks and natural resources.

SB1566 passed the House 61-56-0 and failed in the Senate by 33-21-1.

Pro-Environment Vote: Yes

SB3766: Leucadia Power Plant

Sponsors: Rep. Joseph Lyons and Sen. Donne Trotter

SB3766 provides the highly polluting coal technology of the Leucadia coal gasification facility on the southeast side of Chicago with financing. Governor Quinn vetoed the bill on August 10.

SB3766 passed the House 60- 50- 5 and the Senate by 35- 16- 0.

Pro-Environment Vote: No

SB3442: Prohibition of Municipal Plastic Bag Bans, Fees, and Programs

Sponsors: Sen. Terry Link and Rep. Mike Tryon

SB3442 prohibits municipalities from regulating plastic bags through bans, fees, or takeback programs. This bill bans many of the ways in which a community might reduce its own plastic bag waste.

SB3442 passed the House 72-44-2 and the Senate by 38-15-1.
